# Recognizing Byron Boothe 25 YEARS E.C. Green Cancer Center



### Q: Byron, what led you into Radiation Therapy and to the E.C. Green Cancer Center?

"When I was in radiation therapy school in Evansville, Indiana, in 1995, they sent me to the E.C. Green Cancer Center to observe a low dose rate implant procedure which was performed in the operating room. Then I spent the rest of the day with the staff and observed them treating their patients. The therapists took their time to treat each patient as an individual and showed empathy to them. I also spent time with the physicist who shared his mission and vision of the department as well as patient care. When I returned to Evansville and my professors asked me what I thought, I told them that is the Cancer Center where I wanted to start my career. What impressed me the most on that visit was Dr. Murray and the staff. They were professional and caring about their patients. Over the 25 years that I have been with the E.C. Green Cancer Center, the technology and staff have changed, but the care remains the same."

### Q: 25 years is a long time, so would you share what has most influenced your decision to stay with E.C. Green?

"One of the main reasons I have stayed at E.C. Green Cancer Center for 25 years is because of our caring and compassionate staff. I am proud to be a part of a team-oriented department where patients come first. We have a couple of staff members that have worked at other centers that say we have a higher quality of care because of our attention to detail when treating patients, and they would want their family members treated with us. That is one of the biggest compliments we could receive."

"We also have the latest state-of-the-art technology that allows therapists to maximize their skills, which allows for the most precise treatments. The center has grown from one linear accelerator to two linear accelerators. Procedures have also improved, and we now can perform high dose rate implants instead of low dose rate implants that I observed 25 years ago. Since we have the most modern technology, and Dr. Murray is very well-known and respected in the Radiation Oncology community, we can keep patients closer to home. It has been a privilege to work at E.C. Green Cancer Center for 25 years and to take part in the care of so many wonderful people."

### Q: What do you find most rewarding about working at E.C. Green?

"One of the most rewarding things about my job is getting to collaborate with people who genuinely care about helping cancer patients. We see patients daily for weeks and get to learn about them and their lives. It is so extremely rewarding when I see cancer survivors that we treated many years ago and they are doing well."

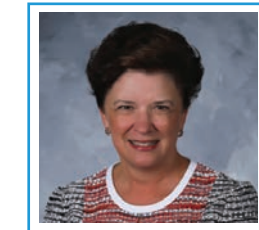

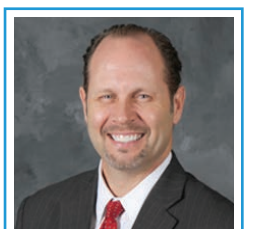
